If you currently have an under 17 free swim pass and are a Manchester resident, you do not need to re-register – simply continue to enjoy your free swimming during school holidays. To register, please complete this application form and take to your local pool. To be eligible for this programme you must be aged 16 or under, and live in Manchester. Proof of age and residency is therefore required at the time of registration. Proof of age could include a bus pass, passport, birth certificate etc. Proof of residency could include a utility bill, such as your family's Council Tax bill. Includes access to all public swimming sessions. Please check your local pool for times of activities. Please note swimming lessons, aquatone sessions and instructor-led sessions are not included.
